

TERMS & CONDITIONS – TRANSFER STATION TIPPING

- 1. Talking Rubbish are a registered with the Environment Agency as a Waste Carrier and all onward disposal site are correctly licensed or approved.
- 2. Customers using Talking Rubbish Transfer Station do so entirely at their own risk. Talking Rubbish accepts no responsibility for damage or injury of any nature that may occur to persons or vehicles using this site.
- 3. All visitors must report to the site office.
- 4. All customers must wear the appropriate PPE including hard hat, safety boots, and hi-vis at all times when on site. A hard hat and hi-vis can be provided if needed.
- 5. No tipping will be permitted without a valid and in-date Waste Carriers Licence.
- 6. Materials deposited on site must be accompanied with a completed and accurate controlled Waste Transfer Note.
- 7. The Customer is responsible for fulfilling their duty under Regulation 12 of the Waste (England and Wales) Regulations 2011.
- 8. Only waste permitted under the waste permit/licence may be deposited on site. The list of wastes are shown in Appendix A of this document.
- 9. Under Duty of Care, it is the responsibility of the waste producer / customer to characterise and classify their waste appropriately. By agreeing with these T&C's, you are agreeing to this.
- 10. Talking Rubbish reserves the right to refuse any material which it considers to be objectionable, unsuitable, and/or non-conforming to deposit. Any unauthorised waste tipped will be loaded back onto the vehicle.
- 11. Hazardous waste will not be accepted on site. This includes (but not limited to):
 - Electrical appliances
 - Fluorescent light tubes
 - Batteries
 - Fridges, freezers & air-conditioning units
 - TV's and monitors
 - Paints (including residues inside paint cans)
 - Solvents, aerosols & gas canisters
 - Liquids; oils, fuels & other automotive fluids
 - Asbestos not in a mixed skip load
 - Grade D Hazardous Wood waste including creosote and CCA treated railway sleepers telegraph poles and any other wood items treated with creosote
 - Clinical or medical waste
 - Toxic materials
- 12. Gypsum / plasterboard must be segregated at the top of the skip load or ordered under a segregated gypsum skip load.
- 13. Customer must complete site induction prior to tipping and this will take place on the customers first visit to site.
- 14. Payment will be required prior to tipping, unless hold a credit account with Talking Rubbish.
